## ***Contributors***

**Madeleine Akrich** is a research fellow at the Centre de Sociologie de l'Innovation of the Ecole Normale Supérieure des Mines in Paris. Her research is on the sociology of technology; she has published several articles on the process of technology transfer to less-developed countries and on user representations during the innovation process.

**Malcolm Ashmore** is lecturer in sociology at Loughborough University of Technology. His interests are in the sociology of scientific knowledge, expertise, and reflexivity; currently, he is investigating the role of the debunker in cases of discovered "fraud." He has published *The Reflexive Thesis* (University of Chicago Press, 1989) and, with Michael Mulkay and Trevor Pinch, *Health and Efficiency: A Sociology of Health Economics* (Open University Press, 1989).

**Wiebe E. Bijker** is associate professor at the University of Limburg, The Netherlands. His present research focuses on the implications of recent work in the sociology and history of technology for issues of control, intervention, and social change; his work encompasses technology assessment, ethics, and theories of society.

**Geof Bowker** is director of the National Archive for the History of Computing at the Center for the History of Science, Technology and Medicine, University of Manchester. His research interests include the history of cybernetics and computing. He has written extensively on the history of Schlumberger.

**Michel Callon** is professor of sociology at the Ecole Normale Supérieure des Mines in Paris and director of the Centre de Sociologie de l'Innovation. His current research focuses on the dynamics of techno-economic networks and on scientific research policies. He has edited, with John Law and Arie Rip, *Mapping the Dynamics of Science and Technology* (Macmillan, 1986) and *La Science et ses réseaux* (La Découverte, 1989).

**W. Bernard Carlson** is assistant professor of humanities in the School of Engineering and Applied Science at the University of Virginia. His area of expertise is the history of American technology and business, and much of his research has focused on understanding the social and cognitive dimensions of invention and innovation. He is author of *Innovation as a Social Process: Elihu Thomson and the Rise of General Electric, 1870–1900* (Cambridge University Press, 1991).

**Adri de la Bruhèze** is currently a guest researcher at the Twente University of Technology in The Netherlands. He is interested in the history, sociology, and politics of technology, and his current research is on the history of radioactive waste technology in the United States and The Netherlands.

**Bruno Latour** was trained in philosophy and anthropology and is now professor at the Ecole Normale Supérieure des Mines in Paris and at the Science Studies Program of the University of California, San Diego. He is the author of *Laboratory Life* (1979, with Steve Woolgar), *Science in Action* (1987), and *The Pasteurization of France* (1988). He is currently working on technology and on the social history of French science.

**John Law** is professor of sociology and director of the Centre for Technological and Organisational Practice at the University of Keele. His current research interests include the management and organization of scientific research, the history of military aviation, and the relationship between power and technology. His most recent publication is an edited collection on the last topic called *A Sociology of Monsters: Essays on Power, Technology and Domination* (Routledge, 1991).

**Thomas J. Misa** is assistant professor of history at Illinois Institute of Technology. He has published empirical studies on the history of chemical engineering and transistor technology as well as analytical studies of technological determinism and risk; he is a contributing editor of *Science, Technology & Human Values*. His forthcoming book on the rise of American steelmaking between 1865 and 1925 analyzes the interaction among scientific knowledge, technological processes, and industrial structures.

**Michael Mulkay** is professor of sociology at the University of York. He has written on art, death, and humor as well as on science. Over the years, his approach to the study of science has changed considerably, as illustrated by his most recent book, *Sociology of Science: A Sociological Pilgrimage* (Open University Press and Indiana University Press, 1991).

**Trevor Pinch** is associate professor in the program on Science, Technology and Society at Cornell University. His current research interests include the sociology of scientific instrumentation, the sociology of technology, and the rhetoric of selling, sales promotion, and advertising. He is the author of *Confronting Nature: The Sociology of Solar Neutrino Detection* (Reidel, 1986).
